## **Telstra and Opticomm SIP Agreed Operational Measures**

## 1 PREMISES TRANSITION DATES

Telstra and Opticomm have agreed that there will be an incremental series of dates that will be the Premises Transition Dates applicable to the transitioning Premises.

The table below sets out the Premises Transition Date that applies to a particular Premises where a Telstra-Equipped Service is requested by a carriage service provider and at the time of the carriage service provider's request no Telstra -Equipped Service is supplied to that Premises.

For clarification, the earliest Premises Transition Date that applies to a particular Premises will be the Premises Transition Date for that Premises.

Premises Transition Date		Premises to which that Premises Transition Date applies
1.	The date that is 12 weeks prior to the System RFS Date	Premises in the relevant FDH area where additional network capacity would be required to fulfil an order for Telstra- Equipped Services.
2.	The date that is 4 weeks prior to the Order Stability Period Commencement date	Premises in the relevant FDH area where a lead-in cable would be required to fulfil an order for Telstra-Equipped Services.
3.	The Order Stability Period Commencement date	All Premises in the relevant FDH Area.

## 2 OPERATIONAL MEASURES

Where Telstra receives a request from a carriage service provider for a Telstra-Equipped Service prior to the Premises Transition Date for the relevant Premises, Telstra will process the request. If Telstra considers that it will be unable to commence supply of the Telstra-Equipped Service prior to the Order Stability Period Commencement date, Telstra will handover the request to Opticomm.

Where Telstra receives a request from a carriage service provider for a Telstra-Equipped Service on or after the Premises Transition Date for the relevant Premises, Telstra will ask the relevant carriage service provider to direct their request to Opticomm.

## 3 GLOSSARY

Capitalised terms used in this Schedule have the meanings given below, and, if not defined below, have the meanings given in the Transition Roadmap and Schedule published on Telstra's website at <a href="https://www.telstrawholesale.com.au/products/product-exits-and-solutions/fibre-access-broadband.html">https://www.telstrawholesale.com.au/products/product-exits-and-solutions/fibre-access-broadband.html</a>:

**Premises** means an individual premises within a transitioning FDH Area.

**Premises Transition Date** means, in respect of a Premises, the relevant date set out in the table in section 1 above.

**Telstra-Equipped Service** means a service which satisfies the following conditions:

- (a) the service is one in relation to which Telstra is in a position to exercise operational control of:
  - (i) all or part of the telecommunications network in the designated service area; or
  - (ii) the kinds of services that are supplied using the telecommunications network in the designated service area; and
- (b) the service is either:
  - (i) a carriage service which Telstra supplies to end-users at the premises in a designated service area; or
  - (ii) an eligible service which Telstra supplies to another carriage provider in order that the other carriage service provider can provide qualifying carriage services to end-users at premises in a designated service area.
